



THIS APPLICATION coming on for hearing at Vancouver, British Columbia, on October 15, 2009, AND UPON hearing Salim M. Hirji, counsel for the Petitioners; and those counsel listed in Schedule "A" hereto; AND ON READING the pleadings and other materials filed herein; AND pursuant to the *Companies' Creditors Arrangement Act*, R.S.C., 1985 c. C-36, as amended (the "CCAA"), and Rules 3, 10, 12, 13(1), 13(6), 14 and 44 of the Rules of Court and the equitable and inherent jurisdiction of this Honourable Court; THIS COURT ORDERS THAT:

1. the sale of the following lands and premises:


